## SB 1383: CALIFORNIA'S SHORT-LIVED CLIMATE POLLUTANT REDUCTION STRATEGY

**PURPOSE:** To reduce methane generation, all businesses must divert organic material - food scraps, food-soiled paper, and yard waste - away from the landfill, and place in compost containers for collection.

**Effective January 1, 2022.**

### REQUIREMENTS:

- Place organic materials like food scraps, food soiled paper, and yard waste below in your green compost cart or bin. If your business is a Tier 1 or Tier 2 Generator, you are required to recover and donate excess edible food.

**Applicable to  
Tier 1 & Tier  
2 businesses**

All businesses and residents in the City of Dublin must divert organic material (food, food-soiled paper, and yard waste). Citations and fines will be issued for non-compliance.

Tier 1 and Tier 2 businesses (typically grocery stores, hospitals, large restaurants, and public schools) are required to recover excess edible food for donation. In Alameda County, SB 1383 is implemented and enforced under the Organics Reduction and Recycling Ordinance, which was passed by local government agency StopWaste. StopWaste partners with the City of Dublin, Amador Valley Industries, and the Alameda County Department of Environmental Health to help sites comply and enforce the law when needed.

## AB 827: FRONT-OF-HOUSE RECYCLING STATIONS

**PURPOSE:** Provide compost, recycling, and garbage sorting opportunities for customers. These receptacles are required for collection of waste generated by customers from products purchased and consumed on site. **Effective July 1, 2020.**

### REQUIREMENTS:

- Receptacles must be visible and easily accessible.
- Receptacles must be labeled and colored **Green (Compost)**, **Blue (Recycling)**, and **Gray/Black (Garbage)** for easy identification.
- Receptacles must be collocated in a 3-stream formation:



### WHO IS EXEMPT?

Full-service restaurants with all reusable dishware, as long as compost and recycling receptacles are provided in back-of-house for employees. Food and beverage establishments are considered full-service restaurant if:



**1** Customers are assigned or escorted to an assigned eating area.



**3** Customers' food and beverage orders are taken after being seated.



**2** The food and beverage orders, as well as any other requested items, are delivered directly to the customers.



**4** The check is delivered directly to the customer at the designated eating area.

## AB 1276: SINGLE-USE FOODWARE ACCESSORIES AND STANDARD CONDIMENTS ON REQUEST

**PURPOSE:** To reduce single-use waste, retail food facilities and food delivery platforms are required to only provide foodware accessories and condiments on request. **Effective January 1, 2022.**

### REQUIREMENTS:

- Only provide single-use accessories to customers upon request.
- Self-service accessory stations are compliant with the law.
- Condiment packets (ketchup, mustard, soy sauce, etc.) should only be included in an order on request of the customer.
- No bundling of single-use accessories or condiments (no utensil packets). Accessories are napkins, straws, utensils, stirrers, spill stoppers, chopsticks, lids, and any other similar accessory or accompanying disposable foodware item used as part of food or beverage service. Below are examples of accessories:
