

## Dublin City Council Eliminates Parking Requirements in the Downtown Dublin Specific Plan Areas



On January 9, 2024, the City Council adopted a resolution **amending the Downtown Dublin Specific Plan to eliminate parking requirements** in the Retail District, Transit-Oriented District, and Village Parkway District.

The amendments implement recent changes in state law and recommendations from the Urban Land Institute. **The elimination of parking requirements extends beyond the state-required one-half-mile radius of the BART station to include all properties within the Downtown Dublin Specific Plan area.**

## Stormwater Protection Responsibilities for Parking Lot Pavement Maintenance for Owners



Owners of parking lots and companies that maintain them are responsible for meeting the stormwater requirements of the Municipal Regional Stormwater Permit 3 for pavement maintenance activities. These requirements include pollution prevention practices during construction; installation of permanent low impact development stormwater controls; and may include trash capture controls.

## State Waste and Recycling Mandates for Restaurants



The City of Dublin will be mailing letters to Dublin restaurants to help them comply with applicable state laws and requirements related to solid waste and recycling. The mailing includes a letter and resources on Senate Bill 1383, Assembly Bill 827, and Assembly Bill 1276, described below.

- **SB 1383** requires businesses and tenants to properly sort recyclable and compostable materials.
- **AB 827** requires restaurants and food facilities to provide recycling and compost sorting opportunities for customers to sort waste generated from products purchased and consumed on site.
- **AB 1276** requires retail food facilities and food delivery companies to provide single-use food ware accessories and condiments upon request only or at self-service stations.

The letter also encourages businesses to contact Amador Valley Industries for technical assistance and resources on proper sorting.

## New Reporting Requirement for Small Businesses

The **Corporate Transparency Act**, which took effect in January 2024, requires small businesses with fewer than 20 employees to report their ownership information to the Department of the Treasury's Financial Crimes Enforcement Network as part of an effort to curb money laundering and illicit financial operation. Existing companies have one year to file and new companies must file within 90 days of creation or registration.

## Important Notices for Businesses Regarding Disability Access and Identification of Single-User Toilet Facilities



The City of Dublin is providing the following notifications to businesses to help ensure businesses are aware of these requirements by law.

### Compliance with Disability Access Laws

Under federal and state law, compliance with disability access laws is a serious and significant responsibility that applies to all California building owners and tenants with buildings open to the public. ### Single-User Toilet Facilities

The California Health and Safety Code, 118600, states in part: "All single-user toilet facilities in any business establishment, place of public accommodation, or state or local government agency shall be identified as all-gender toilet facilities by signage that complies with Title 24 of the California Code of Regulations, and designated for use by no more than one occupant at a time or for family or assisted use."

# 2024 Grants Available for Small Businesses



## **Verizon Small Business**

Business owners that sign up for the free [Verizon Small Business Digital Ready](#) online community will be eligible to apply for a \$10,000 grant. Grant applications are accepted throughout the year.

## **The National Science Foundation's America's Seed Fund**

This fund provides millions in grant funding to small businesses and startups with big ideas. Applicants submit project pitches any time during the year, and if invited to submit a proposal, could be funded. The grant program provides roughly \$200 million per year to eligible businesses.

## **National Association for the Self-Employed (NASE)**

The [NASE Growth Grants program](#) provides up to \$4,000 grants on a rolling basis throughout the year. Applicants must be members of NASE. Grants can be used for marketing, advertising, hiring employees, expanding facilities, and other specific business needs.

## **Halstead Grant**

The [Halstead Grant](#) is an annual award for emerging silver jewelry artists. Applicants submit answers to 15 business questions in addition to their design portfolios. The grand prize is a \$7,500 cash grant plus other benefits. The application deadline is Wednesday, May 1, 2024.

## **ARTSFUND Grant Program**

The [ARTSFUND Grant Program](#) supports the Alameda County nonprofit arts and cultural organization serving Alameda County community members. Grants will be awarded to qualifying organizations providing arts and cultural programs in the areas of visual art, dance, theater, music, literature, poetry, cultural events and traditions, and other related forms. The standard grant award is \$2,000 to \$3,000. The application deadline is Thursday, February 15, 2024, 5:00 p.m.

## **StopWaste Grants**

StopWaste is offering \$1.1 million in grant opportunities to nonprofits, businesses, and institutions with projects aimed at increasing individual, business, and community involvement in the prevention of waste in Alameda County. Funding priorities are related to projects that focus on waste prevention, reuse, and recovery of food, goods, and materials as well as development, marketing, and products made with recovered materials. Proposed projects must be located in and/or service the residents and/or businesses of Alameda County. Grants up to \$30,000 are awarded and the application deadline is Thursday, March 14, 2024. ### **evFleet Consulting Program**

Business owners with a commercial fleet can get free expert help creating an electric vehicle plan. The [evFleet Consulting Program](#) helps business owners understand electric truck specs, charging solutions, and incentives to keep costs low and optimization high. Services are available through June 2024.

### **Commercial Induction Rebate**

[Ava Community Energy](#) will provide up to \$17,500 in rebates to restaurants and businesses for the purchase and installation of induction cooktops, ranges, woks, portable cooktops, and other required electrical upgrades. Funding is available for retrofit and new construction projects. Rebates are available on a first-come, first-served basis until funds are expended.
