Residential Parcel \$1,675.65/unit

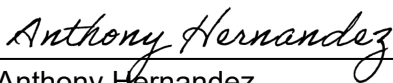
1. Alameda County only accepts assessments in even pennies so they can split the property tax bill into two equal payments. Therefore, some assessments may be rounded down one penny.

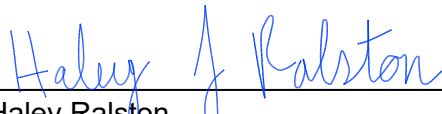
