



Dublin Police Services Taxi Driver Application Requirements & Instructions Dublin Municipal Code 6.76



In accordance with Dublin Municipal Ordinance 6.76.070, it shall be unlawful for any driver to drive or operate any taxi cab in the City without having in his/her possession a permit in writing from the Chief of Police, and without the owner of the taxi cab company having obtained a permit as herein required. To be eligible for a driver's permit, the following requirements must be met:

- 1) Applicant for a Taxi Driver's Permit must show evidence that he/she has a valid California Driver's License to operate the type of vehicle for which the permit is sought.
- 2) Applicant for Taxi Driver's Permit shall be fingerprinted and photographed and his/her record filed with the Police Department.
- 3) Each Taxi Driver's Permit shall set forth the name of the owner by whom the driver is employed and shall be valid only so long as he/she is employed by such owner.
- 4) No Taxi Driver's Permit shall be granted to any person less than eighteen years of age.
- 5) Taxi Driver's Permit may be denied, suspended or revoked upon substantial evidence of facts of either physical or moral deficiencies of the applicant or permittee, which would render such person incompetent to operate a taxicab.

The fully completed Taxi Driver's Permit Application form **must be accompanied** by the following:

- Two 2" x 2" color photos;
- Completed Live scan fingerprints;
- Copy of valid California Driver's license;
- Application Fee of \$216.00

**Processing of your application may take up to 6 weeks.
You will be notified by telephone when your permit is ready for pick-up.**

Please note that your application form and payment WILL NOT be accepted by Dublin Police Services staff unless all of the above requirements have been met and any NON-REFUNDABLE fees are paid .
